When installed and finished according to our published installation instructions and accepted engineering standards, our Power Products® will perform in accordance with our current published specifications for the lifetime of your home or building.

Warranty Limitations

Anthony Forest Products Company must be given a reasonable opportunity to inspect the product before it will honor any of the claims under this warranty. If, after inspection and verification of the problem, we determine that there is a structural failure covered by the warranty, we will pay the owner of the structure an amount of money equal to the reasonable cost of the defective product, or at our option, replace any defective product. This warranty does not cover the costs of installation, removal of the defective product, or reinstallation of replacement product. Checks, cracks, or splits of Power Products® resulting from the natural physical properties of wood are not covered, unless the condition causes a structural weakness.
